 - Goal for the Class Council Equity Position:
 - **a.** Create more equity focus on the class council
 - **b.** Establish more collaboration between class council, D&A, and AS equity roles
 - **c.** To have a person sit in on council meetings to bring ideas and concerns forward regarding disability and accessibility

Speaker's List

- Duva: Appears to be a lot of equity aspects to the role; what would a non-equity D&A side of the portfolio look like?
 - Katrina: Many topics discussed at class council meetings are consider from an individual standpoint. The goal is to have some to sit in on the class council meeting to focus on accessibility, inclusion and the equity lens. Can be further highlighted in the position.
- Imran: It says there will be two meetings with the D&A committee. Would this individual be on the class council *and* the D&A?

- Katrina: Might be a good idea for this position to also sit on the D&A committee so they are always attending meetings.
- Mary: How does this position fit in with the AS equity representatives? Will they work together or may it be redundant? There are also a lot of positions that are sometimes hard to fill.
 - Katrina: It might be a good idea to test out for a year; if it is not received well, we will take the feedback.
- Bryan: Seems like there is a large focus on the D&A part of the role and there has been a lot of applicant fatigue; as we add more positions, we dilute the council, and it becomes more difficult to work with each other. Since there is such a focus on D&A, has there been discussion to put this position on the D&A instead of class council as opposed to an elected role.
 - Katrina: I will bring this up with Abbi to see if this may be effective.
 - Soane: To respond to Bryan and Imran, we did not want this to be entirety focused on the D&A because there are many other great portfolios. We mentioned two meetings to incorporate other equity components. We want someone to be there at class council meetings to ensure equity topics are be considered and discussed properly.
- Molly: One part of the circular reps role has been to ensure that stuff in school is accessible which is where AS does not have much domain. We recognize that there were a lot of crossovers or redundancies in the role; perhaps we add to portfolios that are already there rather than adding a new role.
- Candice: Because there are a lot of redundancies, we have discussed a google doc where we share our current projects so there is less overlap and more collaboration. The position is a good idea to have diversity of voice – a trial role could allow us to modify it moving forward.
- Tony: How will there be a connection between this position and the current AS equity committee? I recommend the equity officers to be looped in to see how their roles can be benefitted.
 - Katrina: Class councils have be having difficulties with navigating event planning with the new disability and accessibility policies. I think it will be important to include the equity positions of AS in the planning and implementation of this role. The largest gap we've noticed at class council meetings is having someone to always consider topics of discussion from an equity and inclusion perspective.
- Chloe: Why would this be a voted in position when D&A does not have any voted in positions?
 - Katrina: This person would be sitting on class council unlike D&A members. Since they will be integrated it may be best that they are voted in.
 - Sloane: This is not a D&A role, though they will be sitting in on some D&A meetings. They will be there to ensure accessibility and equity is brought forth in class council conversations.
